Whereas 79% of the company's shares have been sold by its financial investors eCAPITAL AG, IBB Beteiligungsgesellschaft mbH, Strategic European Technologies N.V. and JTI, Inc., the remaining 21% of the shares are kept by the three founders and managing directors of the company, but are subject to call options of TXT. The transaction is expected to be closed on or about 1<sup>st</sup> April 2016.

PACE, founded in 1995, serves the aviation and aerospace industry worldwide, providing innovative, proprietary software and services that help to design, configure, evaluate and operate a growing portion of the global aircraft fleets. PACE has a customer base of over 50 large companies such as Airbus, Air France & KLM Engineering, Boeing, COMAC, Delta Air Lines, Embraer, GE Aviation, Lufthansa, Rolls-Royce, Safran Group and Sukhoi.

TXT, founded in 1989, is an international software products and solutions vendor and a leader in "Strategic Enterprise Solutions". The company has been listed at the Italian Stock Exchange since July 2000 and avails of around 700 employees. The consolidated revenues of TXT amounted to € 55.9 million in 2014. TXT is headquartered in Milan and has subsidiaries and branches in Australia, Canada, France, Germany, Hong Kong, Singapore, Spain and the UK.
