RASCHKE VON KNOBELSDORFF HEISER advised on the sale of the leading German wire manufacturer BERKENHOFF to the Chinese POWERWAY GROUP

RASCHKE VON KNOBELSDORFF HEISER (RKH) has advised the shareholders of the German Berkenhoff GmbH in connection with the sale of the long-established metalworking company to the stock-market listed Powerway Group based in the East Chinese megapolis Ningbo.

The 125-year-old Berkenhoff GmbH is a leading manufacturer of innovative high-tech precision wires. The company at its two sites currently employs about 440 employees. Its annual turnover roughly amounts to € 100 million. After having experienced difficulties from 2004 to 2009 under control of various financial investors, a change in Berkenhoff's shareholders occurred and the company appointed the German consulting firm nexpert AG to support Berkenhoff in its phase of restructuring. Nexpert AG, with offices in Hamburg, Dusseldorf, and Munich, specializes in operative and financial restructuring of industrial enterprises.

Following the successful restructuring of Berkenhoff, various strategic investors from Germany, France, Russia, and China competed for acquiring Berkenhoff. Eventually, the Chinese Powerway Group prevailed in this months-long auction process. Powerway is a global leader in providing nonferrous alloy bars and precision wires just as those being produced by Berkenhoff. Powerway employs about 440 employees. Its annual turnover amounts to around € 800 million. Yet, the transaction, the details of which are being kept confidential, is subject to approval of the competent antitrust authorities.
