## RKH ADVISES LLOYD FONDS AG ON INVESTMENT IN BERLIN-BASED FINTECH GROWNEY

Raschke von Knobelsdorff Heiser (RKH) has advised Lloyd Fonds AG, a financial institution specializing in fund and asset management and listed on the open market of the Frankfurt Stock Exchange (Scale), on its investment in the Berlin-based FinTech and robo-advisory company growney GmbH.

Lloyd Fonds AG will initially acquire a 17.75% stake in the share capital of growney GmbH by way of a cash capital increase with a contribution of EUR 3 million. At the same time, Lloyd Fonds AG has secured the acquisition of up to 100% of the shares in growney GmbH by concluding option agreements with the majority shareholder and founder as well as all other shareholders of growney GmbH. The acquisition of these shares is to take place in several stages, namely against the issue of new shares in Lloyd Fonds AG on the basis of a capital increase against contributions in kind, the subscription to a further capital increase for cash at growney GmbH by Lloyd Fonds AG and the acquisition of the remaining growney shares against cash payment. The closing of the transaction is currently still subject to the successful conclusion of the owner control proceedings pending with the German Federal Financial Supervisory Authority (BaFin).

For Lloyd Fonds AG, the investment in growney GmbH is the basis for the further expansion of the previous business segment "LAIC" of the Lloyd Fonds Group into the business segment LLOYD DIGITAL within the framework of a consistent two-brand strategy.

RKH acted as corporate and capital markets counsel to Lloyd Fonds AG, advising on the structuring and conception of the transaction, conducting the corporate red flag due diligence, drafting the contractual documentation and assisting in the negotiations with the sellers. RKH was represented by the partners RKH partners Dr. Kristian J.
